About 8(a) Certification: 8(a) Disadvantaged Small Business



The 8(a) Business Development Program presents a critical opportunity for disadvantaged small business owners. Achieving 8(a) certification grants access to government contracts specifically set aside for program participants. Furthermore, this certification offers a range of support services including business counseling, procurement guidance, mentorship, training, financial assistance, and various forms of technical and management support to foster business growth and success.

8(a) Eligibility Requirements:

- Business must be 51 % or greater owned by an Economically Disadvantaged Individual.
- Leconomically Disadvantage: An Individual who is socially disadvantaged and has not been given fair opportunity to receive proper funding through capital and/or credit.
- Business must be 51% or greater owned by a Socially Disadvantaged Individual.
- Social Disadvantaged Individual: Being subjected to social disadvantage due to your race, ethnicity, sex, gender, or disability must be proven by way of narrative essay with two instances of disadvantage or discrimination.
- Adjusted Net worth \$250,000.00 or less.
- Personal Income Average over the last 3 year period: \$250,000.00 or less.
- Total Personal assets: Less than \$4 Million Dollars.
- Must be considered a Small Business by SBA standards. This is determined by your NAICS codes.
- Must Be US Citizen.
- Must Be in Business for Minimum of 2 years.

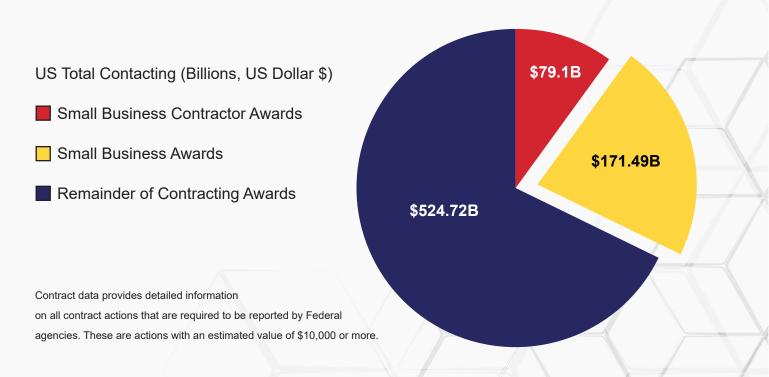

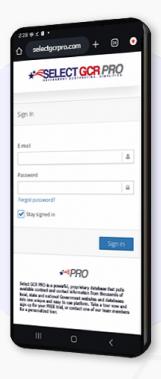


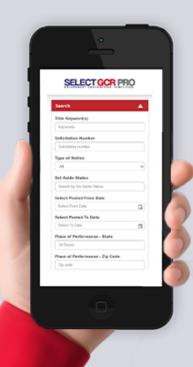
