### 8 (a) BD (Business Development) Certification Eligibility Requirements

 Business Must be 51% or greater owned and Controlled by an Economically Disadvantaged Individual.

Economically Disadvantage: An individual who is socially disadvantaged, and has not been given fair opportunity to receive proper funding through capital and/or credit.

 Business Must be 51% or greater owned and Controlled by an Socially Disadvantaged Individual

Social Disadvantaged: An individual who's ethnicity is African-American, Hispanic-American, Asian Pacific-American, Native-American, Subcontinent-American, or with a documented disability that creates s Social Disadvantage.

- Personal Net Worth = \$250,000.00 or Less (excluding primary residence and business)
- Total Personal Assets of 51% or greater owner (including primary residence and business worth) equals less than \$4 Million
- Personal Income Average over the last 3 year period = \$250,000.00 or Less Must be considered a Small Business by SBA standards
- Must be a US Citizen
- Have not already participated in the 8(a) program
- Must be in business for a minimum of 2 years
