## Veteran-Owned Small Business Certification VOSB / SDVOSB Eligibility Requirements

- Business must be 51% or greater owned by a Veteran US Citizen
- Business must be considered a Small Business by SBA standards
- Veteran can not work for the Federal Government in any capacity
- Veteran can not be active in the reserves
- Veteran holds full operational and strategic management control of the business
- Veteran has the managerial experience of the extent and complexity to manage the entire business
- Veteran must hold highest officer position and title within the business
- Veteran is the highest compensated employee within the business (if they are not then the Veteran will need to present a case that the Veteran Owner not being the highest paid employee benefits the growth of the business)
- Business is properly licensed, structures, and registered on City, County, State and Federal level (If Veteran is unsure we will research and assist with compliances)
- Veteran has no Federal debts or obligations outstanding
- Veteran has a DD214 Form (Client can request a copy at: [https://iris.custhelp.va.gov/app/answers/detail/a\\_id/3057/~/~obtain-a-copy-of-dd-214](https://iris.custhelp.va.gov/app/answers/detail/a_id/3057/~/~obtain-a-copy-of-dd-214))
- Veteran is Honorably Discharged or Other Than Dishonorably Discharged
- Veteran holds no outside employment or secondary business ownership in any business that is outside the business entity applying (If the Veteran does, are the industry hours of the secondary business do not conflict with the 40 hours per week INDUSTRY STANDARD hours of the business applying)
- Veteran Owner works 40 hours per week or greater at the primary office location of the headquarters of the business applying.
- SAM registration "Debt Subject to Offset?" must read: No
